Mr Ken Murray (USA)

Ken and his wife have been very active in the dog world for many years and says his interests are dogs, dogs and dogs. He is a specialist in Irish Setters, English Springer Spaniels and Portuguese Water Dogs and as a professional handler was involved in many breeds from every group. Ken has never judged in Australia so we hope he enjoys his stay in Melbourne for this visit.

Dr Eugenio Aguilo (Chile)
