We observe a very high increase in kennel names registration figures in 2016. This is very positive as it tends to show that the dog world is getting wider and wider, with breeders getting more and more involved in international activities.

Last year, we have completed our specific online tool for “CACIB shows applications” by adding a functionality enabling all FCI members to apply, online, for CACIT, CACIAG, CACIOB, etc. international competitions. This was the result of a very long and huge task which consisted in compiling all national regulations which were used for the awarding of international prizes in the hunting field (CACIT) among our members, and then obtaining the approval of the FCI relevant Commissions and FCI Board. The list of the regulations, national and international – making the trials acceptable for the CACIT - is available in this specific tool.

Most of you are now making use of the LOGIN SECTION on the website and I want to thank you warmly. Digitalization has become a key-word and we try to follow the trends.

This section allows you to get access to a wealth of information (circulars, forms to download, accountancy, Statistics, the tools for the online application for events, FCI logos, decisions of the FCI General Committee and General Assembly, the composition and contact details of all the FCI Commissions, etc.). I strongly encourage the very few remaining countries to embark and join us.

### **SLIDE 12: CIRCULARS, EMAILS & NEWS ([mailing@fci.be](mailto:mailing@fci.be))**

As you have seen, for a couple of years, the FCI has changed its communication system and we do not communicate only by Circulars and Emails but also by News.

2015: 72 circulars, 31 News

2016: 57 circulars, 46 News

We release 2 kinds of News. Some are aimed for the public in general and some are restricted to our members (new tools or new sections on our website, information regarding some FCI internal information (General Assembly, new agreements with Partners or marketing campaigns, ...). Most of these documents are then made available in the section “Download” of the LOGIN section of our website

### SLIDE 13: REVAMPED FCI JUDGES DIRECTORY

A major project, about to be completed, is the total revamping of the FCI Judges Directory. It will be made available in the LOG IN section of the website for the people who will be allowed by their NCO to use it. The new Directory, which will be operative in a couple of weeks (hopefully early January 2018) will offer many more possibilities, will use the correct FCI terminology and will be much more “user-friendly”. Of course, all the data entered by the NCO’s so far will be kept and you will not have to repeat that operation.

Let me also indicate that to date, 76 members have registered so that they can browse in the website and administer their own page of judges.
