# **VICTORIAN CANINE ASSOCIATION INC** RETRIEVING AND FIELD TRIAL COMMITTEE **NOTICE TO MEMBERS**

An election of six members to the Retrieving and Field Trial Committee is to be held pursuant to regulation 6.7 printed in April 2024 Gazette. Nomination forms for election of members representing the undermentioned disciplines for the term 1 August 2024 to 31 July 2028 are now available from the Dogs Victoria administration office.

Two persons representing the retrieving discipline

Two persons representing the pointer and setter discipline

One persons representing the spaniel and retriever discipline

One person representing the utility gundog discipline

Terms of office: Pointer and setter discipline one term of two years, one term of four years

#### **NOMINATIONS**

A person wishing to be a candidate at an election must before twelve o'clock noon on the nomination day deliver or cause to be delivered to the returning officer, a nomination form naming that person as a candidate at the election. Such form shall be completed in all detail and on the prescribed form. Any person eligible to vote may propose or second a candidate. A personal profile form duly completed may be lodged with the nomination form, such profile to consist of not more than 400 words. Should the statement exceed 400 words the excessive words will be deleted from the end of the statement. Where a profile is submitted, it will be supplied to members registered on the retrieving and field trial electoral roll, with dispatch of ballot papers.

### **CRITERIA FOR NOMINATION**

Any VCA member as described in rule 2.6.1 who has for the last two years demonstrated support for the rules and regulations and codes of practice set out by the VCA, and has been one or more of the following:

a competitor in field and/or retrieving events;

connected with trials as a judge, steward or manager;

attended at least one lecture and at least one field training day for the respective disciplines in the last two years shall be eligible to nominate for one position of the RAFT Committee.

A candidate may nominate to represent one only discipline at any one election, and must be enrolled on one or more of the electoral rolls for the retrieving and field trial committee election.

## **ELECTORAL ROLL - RETRIEVING AND FIELD TRIAL COMMITTEE ELECTION**

The electoral roll for the election of members to the retrieving and field trial committee is now open. #### **ELIGIBILITY TO VOTE**

There shall be an electoral roll of voters for each discipline. To be eligible to be placed on the electoral roll voters must be ordinary, dual or life members of the VCA who have within the last two years been one or more of the following:

a competitor in field and/or retrieving events;

connected with trials as a judge, steward or manager on a regular basis;

attended at least one lecture and at least one field training day for the respective discipline

Such a member must apply to be listed on the RAFT electoral roll which will be developed by the VCA through the Gazette and having enrolled, a voter may vote for the discipline(s) for which he/she is eligible according to that enrolment. Eligibility to vote under this clause must be certified as correct by the chief executive.
