## **JOINTPREFIX**

A Prefixmay be co-owned by a syndicate of members, provided that at least the nominee member of the syndicate is a resident of the State of Victoria.

All syndicate members must have met the eligibility requirements to hold a registered breeders prefix.

The syndicate must furnish in writing to the Chief Executive particulars of it constituent contractual arrangements and any change therein that may occur from time to time.

The syndicate must nominate one syndicate member as the representative of the syndicate, and advise the Chief Executive in writing of such nominee.

The syndicate nominee shall receive all notices from Dogs Victoria in relation to the Prefix and any dogs owned by the syndicate, except any transaction which alters the registered ownership of a syndicate dog or prefix. Such transaction must be signed by each member of the syndicate, unless otherwise authorised by the Management Committee.

 $The \,Rules, Regulations \,and \,Codes \,of the \,ANKC \,and \,Dogs \,Victoria \,and \,the \,decisions \,of \,Management \,Committee \,as \,they \,relate \,to \,Joint \,Ownership \,of \,the \,Prefix \,shall \,prevail.$
