Guidelines for Litter Registration

Litter Registration Guidelines (See Dogs Victoria Regulations Part 4 for full registration requirements)

- All owners of a syndicated or jointly owned animal must sign the stud and/or breeder declaration
- All living progeny must be listed on this form
- No progeny will be registered unless the breeder has registered a prefix

REGISTER

MAIN – progeny eligible for conformation exhibition, breeding (unless conditions placed) and export.

LIMITED - progeny ineligible for conformation exhibition, non-recognised colour, not to be bred or not to be exported.

REGISTRATIONS (Refer Dogs Victoria regulation 4.1.3.16) - The service declaration on the Litter Registration application form is to be signed by the owner/s of the sire/semen and provided to the registered owner of the bitch immediately upon satisfaction on the agreed conditions of use of the sire/semen. The signed Litter Registration application form is to be held by the registered owner of the bitch pending registration of the litter

NAME

- Not more than 30 characters, including spaces and breeder's prefix (Refer Dogs Australia regulation Part 6 Section 6 Clause 6.1.2)
- No word that is in the nature of a known prefix or deceptively similar to a known prefix and no prefix except the breeders registered prefix may be used in the dogs name. (Refer Dogs Australia regulation Part 6 Section 6 Clause 6.1.3)
- Cannot contain numerals, apostrophes or hyphens (Refer Dogs Australia regulation Part 6 Section 6 Clause 6.1.1)
- Duplicate names cannot be used with the same prefix
- If your first choice name is refused and there is no second choice, staff have the prerogative to choose a name (Refer Dogs Victoria regulation 4.1.5.5)
- Once a name has been registered and accepted, it shall not be altered unless directed by management committee (Refer Dogs Victoria regulation 4.1.5.6)

Dogs Victoria Regulation 4.1.8 Rectification of Errors

Notice of any mistake in any application for entry in the records of the VCA, must be given in writing to the chief executive as soon as possible after it has been discovered, and thereupon the mistake may be rectified.

COLOURS

The colours, variations and patterns as stated in the current Breed Standards. A Member Body maintains the right to inspect any litter to ensure that the puppies are being registered as the correct colour/s and features in accordance with the Breed Standard and consequently on the correct register. (Refer Dogs Australia regulation Part 6 Section 6 Clause 6.3.1)

GENETIC TESTING

Ensure all genetic testing results are submitted prior to litter registration. For breeds of which this is a requirement, either the ORIGINAL or a certified copy of the original will be accepted.

TATTOO/MICROCHIP

Handwritten microchip numbers will not be accepted. Adhere sticker with 15-digit number or attach a copy of the microchipping certificate. The barcode on the sticker is not needed, only the numbers are required. You may cut off barcode from the sticker.

PUPPY PACKS

Tick in this column for an information packet on Dogs Victoria to pass along to your puppy buyers along with their registration papers. Please refer to scale of charges for postage costs.

Before you submit....

- I have included the sire & dam's registered name as per the PEDIGREE (no pet names)
- I have included the COMPLETE service and whelping dates (including year)
- All owners of the sire have signed the stud declaration
- All owners of the bitch have signed the breeder declaration
- I have circled the register the puppies are to go on
- I have included all puppy names
- I have circled correct sex of all puppies
- I have included all puppy colours (as per the Dogs Australia breed standard) including colour & if applicable, the pattern.
- I have included the microchip barcode
- I have lodged either the ORIGINAL or CERTIFIED COPY Hip & Elbow scores (for breeds of which this is required) & all relevant genetic testing required for my breed (if already lodged with office, please disregard)
- Names are clear and understandable to read.
