- **Hold a conversation** allowing the Trainee to **"Talk the dog"** critiqued and recognise the dog's virtues and areas they would like to see improved.
- The discussion with the Assessor is to develop a greater understanding of the individual dog that was critiqued based on the breed standard and to further develop the Trainee's / Aspirant's assessment skills and the ability to **"Talk the dog"**.
- Trainees **MUST** use the CJC Intensive Critique Form for **ALL** critiques (general and speciality).

Maximum of one (1) intensive critique per breed required. [Total of fifteen (15), to be submitted to the group leader for practical exam approval. *Refer Dogs Victoria regulation 7.14*]
