#### Checklist for Re-Registrations

**Refer to ANKC Regulations Part 6, Sections 3 and 6 for all registration regulations** The following items must accompany the completed and signed application:

## **RE-REGISTRATION OF IMPORTED DOG**

An <u>original</u> Export Pedigree and Ownership Certificate (if two separate documents) issued by the Overseas Controlling Body, indicating the Australian member's name and current residential address. The pedigree must be at least first and second generations complete and the third generation a maximum of four names missing.

AQIS/PEQS final release from Quarantine - this is titled "PEQ Release Report"

Imports from New Zealand require the AirWay Bill and Export Certificate from the Ministry of Primary Industries in lieu of the AQIS/PEQS.

If applicable, Shortened Tail Identification Card application form and accompanying letter (see notes below).

### **RE-REGISTRATION OF IMPORTED SEMEN**

<u>Certified Copy</u> of the Original Pedigree issued by the Overseas Controlling Body. This must be the **original certified copy** or a **stamped witnessed copy by a Justice of the Peace**.

The pedigree must be at least first and second generations complete and the third generation a maximum of four names missing.

Please note: if you are unable to obtain a certified copy, we will accept a PDF copy sent <u>directly to</u> <u>office@dogsvictoria.org.au</u> from the overseas canine body where the dog is registered. Please ask the owner of the dog to request this from the club.

Photocopy of the Ownership Certificate (this is only required if the current owner's details are not listed on the Original Pedigree).

Collection of Semen Certificate, clearly stating the amount collected. This must be signed and dated by the vet.

Sale/Transfer of Semen Agreement, showing transfer from existing owner. This document must clearly specify the amount of semen to be transferred, and must be signed by both parties.

Biosecurity Release from Quarantine.

For imported dogs with shortened tails, please include a statement from a veterinary professional (or in the case of dogs imported from New Zealand, an accredited NZKC tail bander) to indicate that the dog's tail has been legally shortened for medical/therapeutic reasons in accordance with the local jurisdiction of the region where it was whelped. Please ensure that an Application for Shortened Tail Identification Card is also completed. Refer to Dogs Victoria Regulation 4.1.3.8.3.4

#### ANKC Regulations Part 6, item 3.2:

All documentation submitted with an application for re-registration of an imported dog and/or semen must be in English or accompanied by an official document translated in English by an authorised interpretation/translation service, e.g., an Australian or State Based Interpreting Service (Added 06/19, 5.6)
