Introduction

Dog judging requires clear, consistent, and efficient decision-making skills. Without the necessary knowledge and expertise, fulfilling this role can be highly challenging. Successful judges are open to listening to others, accepting constructive feedback, recognising both strengths and weaknesses, and appreciating the diversity among dogs and exhibitors.

The Conformation Judges Training Program has been designed to support Dogs Australia members on their journey to becoming Championship Show Judges. The program follows a structured progression, beginning at the Aspiring Judge level and advancing to the Trainee Judge stage.

This is a voluntary, competency based, flexible, and self education program. It provides members with access to a wide range of learning opportunities, including breed lectures, general seminars, field events, and practical judging experience.

Method of Education

Trainees will participate in a program to develop sound knowledge of relevant breeds by engaging in a variety of educational and practical activities, including:

- **Studying:**
 - Breed standards
 - Dogs Australia Glossary of Canine Terms
 - Other relevant literature
- **Research:**
 - Investigate specific breeds
- **Attendance:**
 - Lectures and seminars
 - Field events organized by the CJC (Canine Judges Committee)
- **Practical Experience:**
 - Write critiques
 - Visit kennels
 - Interact with breeders and exhibitors
 - Attend group and breed championship shows
 - Stewarding at events

These experiences help trainees gain broad and practical breed knowledge. Training is based on competency-based principles, with guidance from mentors and accredited assessors.

Dogs Victoria Judges Training Program Structure

Aspirant Level (Year 1)

- Lecture Program: One year
- Theory Exams: 2 total
- Must achieve 75% on each exam
- Any score below 75% constitutes a fail, requiring both exams to be repeated.
 - Repeating the exams requires enrolment in a new training programme.
- Practical Exam: Required

Trainee Level (Years 2 & 3)

- Lecture Program: Two years
- Subgroup Theory Exams: 4 total
- Must achieve an average of 75% over the 4 exams
- Any score below 75% constitutes a fail, requiring all four exams to be repeated.
 - Repeating the exams requires enrolment in a new two-year training programme.
- Practical Exam: Required

Responsibilities of Aspiring and Trainee Judges

1. **Acquire and share knowledge** – through reading, research, observation, questioning, discussion and debate.
2. **Participate** – attend lectures, seminars and dog shows.
3. **Be active** – practice judging, write critiques, seek out opinions and information about breeds, observe judging and exhibits at shows, read extensively, engage in discussions, listen attentively, and both provide and accept constructive feedback.
4. **Be a role model** – act with respect and in a sportsmanlike manner at all times and in all situations.
5. **Maintain decorum** – always conduct yourself in a respectful and professional manner.
6. **Protect confidentiality** – any information regarding the merits (or otherwise) of dogs must remain strictly within the Program.
7. **Adhere to conduct requirements** – any breach of conduct will be referred to the CJC and/or Management Committee for investigation and possible disciplinary action

Dogs Australia National Judge's Code of Practice

Dogs Australia National Judge's Code of Practice

1. A Judge shall act with professional decorum at all times.
2. A Judge shall give every exhibit and exhibitor fair and equal opportunity in each and every class.
3. A Judge shall act in a polite manner whilst carrying out each judging assignment.
4. A Judge shall present himself/herself in attire that is acceptable, appropriate, and comfortable for each judging assignment. Footwear appropriate to the discipline shall be worn.
5. A Judge is required to be punctual in availability to fulfil their judging assignment.
6. If in the judging procedures an exhibit displays an obvious physical impediment or is unable to be handled or can be regarded as savage or vicious the exhibit should be excused from the competition, in accordance with the Dogs Australia Member Body rules/regulations.
7. A Judge shall not enter or exhibit any dog at any Conformation Show at which he or she is appointed to judge.
8. Should an exhibitor offer information to the Judge that may be regarded as designed to influence the Judge, the Judge shall excuse the exhibitor and their exhibit from competition and report the incident in accordance with the Dogs Australia Member Body rules/regulations.
9. Should a Judge be approached to favour or disfavour a particular exhibit the matter is to be reported to the Administrator of the Dogs Australia Member Body.
10. Should a Judge be approached with an inducement and/or bribe to advantage or disadvantage an exhibit the Judge is to report the matter in writing to the Administrator of the Dogs Australia Member Body.
11. A Judge shall not solicit a judging appointment.
12. A Judge shall not solicit or seek entry of any particular dog or dogs.
13. A Judge shall not allow entries for a Conformation Show at which that person is judging to be received at the Judge's address.

14. A Judge shall complete all the requirements of the judging contract promptly. Any verbal acceptance of an assignment by a Judge shall be subject to the receipt of the contract within fourteen (14) days.
15. At the time of completing a contract the Judge shall inform the inviting body of any disability or limitation that could restrict carrying out in full the reasonable handling of all exhibits to be judged.
16. A Judge must not duplicate assignments in the same breeds and or group within a minimum of 3 months of each other and within a minimum of 200 kilometres at Championship Shows. Note: This will not apply to Neuter only shows.
17. A Judge shall honour each contract and will not be free to accept an alternative contract that will affect his or her availability to fulfil the original contract except with the written dispensation of the contracting Club.
18. Accommodation provided to the Judge to fulfil an assignment is for the Judge only except where prior mutual agreement has been reached with the sponsoring body for variation.
19. A Judge shall be responsible for the cost of all personal telephone calls, alcoholic beverages and any personal laundering except where mutual agreement has been reached with the sponsoring body at the time the contract is accepted.
20. A Judge who withdraws from any contracted appointment for any reason shall not be permitted to judge at any other canine event wherever held on any date that would prevent him/her from attending the originally contracted event, unless dispensation has been granted in accordance with Clause 17.
21. Judges must not smoke nor drink alcohol in the ring.
22. At an exhibition, an officiating Judge shall not use electronic devices whilst carrying out judging appointment in the ring unless confirming a breed standard or when critiquing. Electronic devices must not be used for communication purposes while judging
23. Judges shall not criticise by act or word the work of other judges, nor offer criticism of any previously judged dog(s) to anyone including other officiating judges during the course of the show. Except for authorised ringside mentoring.
24. All judges must judge exhibits in accordance with their relevant Dogs Australia breed standard.

Aspiring Program

Requirements:

- Attendance at all lectures and both hands on events is **compulsory**.

Modules:

1. Introduction, Interpreting Standards and Study Techniques
2. Critiquing and Glossary of Terms
3. Canine Anatomy
4. Gait and Movement
5. Ethics and Responsibilities / Rules and Regulations
6. Ringcraft Theory
7. Ringcraft Practical & Hands On (two sessions)

Theory Examinations:

- **Theory Exam – July**
 - Content: Rules and Regulations, Anatomy, Glossary of Terms
 - Pass Mark: 75%
 - Content: Aspirant's nominated group
 - Pass Mark: 75%

Assessment:

- **Practical Assessment –**
 - Requirement: Complete and pass

Outcome:

- Upon passing the Practical Examination, the aspirant shall be listed as a **Dogs Australia Open Show Judge** for that breed or group.
- Participants are **eligible to apply** for the Trainee Program, either group or single breed
- Should an aspirant not achieve a pass result, the Aspirant will have to re-sit the complete aspirant course

Trainee Group Program

- Attendance at ALL scheduled Field Days/Nights through the four subgroups is compulsory. Failure to attend will render the trainee ineligible to apply for a Practical Exam.
- A trainee who is unsuccessful in their Practical Exam OR previously passed their theory, must attend ALL Field Days/Nights in the year they wish to apply for a Practical Exam.
- A trainee who is unsuccessful in their Practical Exam must attend a minimum of 75% of lectures in the year they wish to apply for a Practical Exam.
- A trainee who has previously passed their theory, and wishes to apply for a Practical Exam, must attend 75% of the lectures in the year they wish to apply for a Practical Exam
- A trainee who is unable to attend a lecture must complete the following to obtain credit for the breed(s) covered that night:
 - a) Contact the Group Leader and the Group Leader will supply two or more photos of a dog and bitch for each breed
 - b) For each breed missed, a 1000-word essay be completed consisting of history, form and function of the breed, critique of the dog and bitch and reasoning for Best of Breed. This will be done via a proforma found on the Dogs Victoria CJC site
 - c) This essay proforma(s) must be sent to the Chair, the Group Leader and to the DV Office within 14 days of the lecture.

Trainee Group Program Modules

Year 1

- Subgroup 1: Breed lectures and field day
- Submit an application form
- Sit Theory Exam
- Subgroup 2: Breed lectures and field day
- Submit an application form
- Sit Theory Exam

Year 2

- Subgroup 3: Breed lectures and field day
- Submit an application form
- Sit Theory Exam
- Subgroup 4: Breed lectures and field day
- Submit an application form
- Sit Theory Exam

Practical Assessment –

- **Requirement:**
 - Have submitted an application form
 - Complete and pass (see Practical Examination Process on below)

Outcome

- Upon successful completion, participant will be licensed as a **Dogs Australia Championship Judge** for that group and is eligible to apply for another group
- Should a trainee not achieve a pass result in a practical examination, to qualify to take a further group practical examination a trainee judge must:
 - Judge an additional 25 dogs
 - Examine and critique an additional seven dogs' intensive critiques
 - Must attend 75% of the lectures in the year they wish to apply for a Practical Exam
 - Attend all field events

Practical Examination Process

Practical Examination Qualification Requirements

To qualify to sit for a Practical Examination, a Trainee Judge must:

- Attend **all lectures and field events**.
- Obtain a **75% aggregate pass** across the four (4) Sub Groups.
- Judge a minimum of **50 dogs** and complete at least **15 intensive critiques**.
- Only **one (1) Practical Examination** may be attempted per calendar year.

Examination Structure

No person shall make any photographic or video record of any part of a Practical Examination

The Practical Examination shall be conducted as follows:

- **Classes:**
 - Two (2) classes, each of a different breed, consisting of five (5) dogs over six (6) months of age.
 - One (1) mixed class of five (5) different breeds (over six (6) months), excluding the two previously used breeds (including varieties of).
- **Assessors:**
 - Three (3) Assessors will be appointed as a Panel for the Practical Examination.
- **Time Allocation:**
 - Trainee Judges are to be encouraged not to spend more than two (2) minutes on each dog.
- **Placings:**
 - For breed and group classes, the Trainee Judge must place the exhibits in order of merit, record the placings, and answer questions on the class.
 - Exact agreement of placings with Assessors is **not required**, but Assessors will consider:
 - The reasoning given.
 - Whether the better dogs are placed at the front of the class and the poorer dogs at the back.
- **Assessment:**
 - Each Assessor must make their own **independent assessment** of Pass or Fail.

Pass Criteria

- To achieve an overall pass:
 - The Trainee Judge must be passed in **all classes** by at least 2 of the 3 assessors

Intensive Critiques

- All intensive critiques require the physical examination by the trainee in the presence of a licenced Dogs Australia Accredited Assessor, who is not a trainee judge currently enrolled in the scheme.
- The intensive critique form **MUST** be completed, discussed, and countersigned by the trainee and licenced Dogs Australia Accredited Assessor on the day.
- A Dogs Australia Accredited Assessor can only sign a maximum of three intensive critiques.
- Approved Distance Trainees must complete the minimum 15 dogs intensive critiques plus essays.

Speciality Intensive Critiques

- Trainee judges are to attend a minimum of one breed, multi breed or group specialty show, for their group within the duration of the scheme.
- Complete a minimum of one written intensive critique at such “specialty show” as a part of the required 15 dogs’ intensive critiques

Please Note

- One critique per breed, this does not include varieties of breeds E.g. poodles, schnauzers
- All exhibits must be at least six months of age or over
- Only the official Intensive Critique Form on the DV website is to be used

Procedure for Conducting Trainee Classes / Sweepstakes at Shows

- To be credited for the required **50 dogs judged**:
 - There must be **only one (1) Trainee Judge in the ring**.
 - Exhibits must be **physically placed, discussed, and signed off** by an **Accredited Assessor only**.
 - All exhibits must be at least six months of age or over
- Each Trainee Sweepstakes Class must have a **minimum of five (5) dogs and a maximum of ten (10) dogs**.
- The Trainee Judge must maintain a **written record** of:
 - Date of the fixture
 - Number of dogs and breeds judged
 - The Trainee Judge's Judging Record Card/Sheet must be signed by an Accredited Assessor after a discussion of the dogs judged and confirmation of the numbers and breeds on the day
 - Sign off by a Show Official is not permitted.
- **Prior approval must be obtained from the Affiliate conducting the Show** before scheduling any Trainee Sweepstakes Class.

Single Breed Training Program

Application Requirements

To enrol in the Single Breed Training Program an Aspiring Judge must:

- Successfully complete the Aspirants program
- Submit a minimum 1,000-word illustrated essay on the relevant breed.
 - The essay must include:
 - A history and description of the breed
 - The breed's purpose
 - All relevant requirements contained in the Breed Standard
 - The essay will be subject to approval by the CJC as conforming with these conditions and demonstrating the required level of competency.
 - The applicant must also attend the breed lecture offered in the Training Program at the time of applying for the Theory Examination.
 - Where conducted (and at the discretion of the Member Body), the applicant must attend:
 - The breed club's Open and Championship Shows
 - The group club's Open and Championship Shows
 - The breed judging at an approved major show (e.g., Royal Show or the major Non-Royal Show in each State).

To qualify for a Single Breed Theory Examination, the Trainee Judge must:

- Have met the requirements above and
- Have submitted an application form.

To qualify for a Single Breed Practical Examination, the Trainee Judge must:

- Have attained a pass in the Single Breed Theory Examination, and
- Have submitted an application form.

Practical Examination Requirements

Single Breed Practical Examination shall consist of:

- One (1) class of a minimum of five (5) dogs over the age of six (6) months, and
- One (1) class of a minimum of five (5) bitches over the age of six (6) months.

The Trainee Judge will be required to:

- Place the classes, and
- Select **Best of Breed** and **Runner Up to Best of Breed**.

The Trainee Judge must not be examined on dogs they own or co-own.

Appointment as Judge

Upon passing the Single Breed Practical Examination, the Trainee Judge shall be listed as a **Dogs Australia Championship Show Judge** for that breed.

Frequently Asked Questions

Can I count dogs I examine at Breed Lectures on my Judging Record?

- **No.** You can only count dogs that you judge: Dogs Australia Reg. 6.1.2 Module 2. Practical Experience: Judging may be in the form of hands-on experience by placing dogs at Open Shows, Sweepstakes, Members Competitions, but not at breed lectures.

How many dogs can a Dogs Australia Accredited Assessor sign off as judged at a non-contracted show?

- Ten (10) dogs

Can I critique dogs at Breed Lectures?

- **No.** Critiques are a training tool and need time for full discussion with an Accredited Assessor to read your critique and have a full discussion on said dog.

What should I do with essays if I missed the lecture?

- Trainees must send 3 copies of essays **within 14 days**, one to each below.
 1. The group leader for checking
 2. Dogs Victoria office: All conformation judges training paperwork emailed to the office is to be sent to: mwilliams@dogsvictoria.org.au
 3. CJC Chair

Can I count dogs I judge in a 'Property Class's at a Speciality Show?

- Only in classes where the **entire dog is judged**.
e.g., Owner/Breeder Class, Interstate Exhibitor Class, Puppy Sweeps Class (over 6 months)
Not Best Head, Colour, Gaited etc where the whole dog is not being judged.

Can I complete Intensive Critiques interstate, and have them signed?

- **Yes**, but they **must** be on the DV Intensive Critique form and completed as required by the Dogs Victoria CJC.
They **must** be discussed and signed off by a Dogs Australia Accredited Assessor **on the day**.
