Dear Dogs Victoria Members,

We hope this message finds you and your furry friends well. As a valued Partner of Dogs Victoria, we wanted to take a moment to provide clarity regarding a specific section of the Product Disclosure Statement (PDS) related to our partnership with Dogs Victoria.

Policy Coverage Explanation

Policy Exclusions:

This policy is designed to cover pets primarily as companions. Therefore, it does not cover cats or dogs that actively participate in commercial or sporting activities, including:

- **Working Animals:** Pets engaged in work on a farm, guarding, or other agricultural duties.
- **Fighting:** Any form of dog fighting.
- **Racing:** Competitive racing events, e.g. greyhound racing.
- **Personal Protection:** Pets trained for personal defence.
- **Gun Sports:** Hunting or shooting activities, i.e. game hunting.
- **Law Enforcement:** Pets employed by police or other law enforcement agencies.

Policy Inclusions:

However, this policy may cover pets involved in the following:

- **Show Dogs/Cats:** Pets participating in conformation shows.
- **Search and Rescue Dogs:** Pets trained for search and rescue missions.
- **Guide Dogs:** Dogs assisting individuals with visual impairments.
- **Assistance Dogs:** Dogs helping individuals with various disabilities.

Coverage for Dogs Australia Activities

We are pleased to confirm that activities listed by Dogs Australia, such as those detailed at <https://www.dogsaustralia.org.au/training-dog-sports>, are covered under this policy. The intent of the policy is to exclude pets actively participating in the actual commercial or high-risk sporting activity, not those involved in competitions or activities that mimic these roles.

For example:

- **Agility:** Your dog participating in agility trials as a sport is covered*.
- **Retrieving & Field Trials:** Dogs engaged in Dogs Australia sanctioned Retrieving & Field Trials are covered*.

- **Herding Trials:** Participation in herding trials as a sport is covered, even though it mimics the actual work of farm herding*.
