- Vehicles, trailers etc are not permitted on any grassed area or inside pavilion at anytime, which includes unloading/loading, set-up/pack up
- Power is available indoors. All electrical items must be test & tagged.
- Pegs in grassed areas must not exceed 25cm in length
- Sites will be allocated to you by Dogs Victoria, you must set up in your allocated site on the day. If you have any additional set up requirements this must be discussed with DV prior to confirmation of booking.
- Vendors will need to be bumped in on site before the event opens to the public at 10am. Vendors will not be permitted to pack down and depart until the event concludes at 4pm to reduce the vehicle traffic whilst pedestrians are on site.
- **You may need to bump in over a distance of up to 20 m with grass & paths. You must plan accordingly and provide your own trolley/equipment to assist with your set up & pack down**

PUBLIC AND PRODUCT LIABILITY

GENERAL TERMS & CONDITIONS

- Stallholders must not drive vehicles on the grassed areas or indoors at any time
- Stallholders are responsible for providing their own gazebo, table, chairs & equipment for bump in & out
- Notification of non-attendance is required. No refunds will be given for non-attendance
- No refunds will be given in the event of cancellation. In the case of inclement weather the event maybe moved indoors wherever possible. In the case of extreme weather the event may be cancelled, especially in extreme heat
- Stall holders must be operational for the duration of the event (10am – 4pm) unless prior arrangements have been made.
- Stall holders must bump in within the designated time frame before the event opens to the public, and bump out once the event is closed to the public to reduce vehicles on the grounds whilst there is heavy pedestrian traffic.
- Stallholders may distribute advertising, promotional materials, flyers, etc. at their designated stall only.
